4. FIRST AID MEASURES

Inhalation: Move exposed person to fresh air. Get medical attention if

Avoid breathing vapour or mist. Provide adequate ventilation.

Environmental precautions: Avoid dispersal of spilt material and runoff and contact with soil, waterways, drains and sewers.

Small spill: Dilute with water and mop up if water-soluble or absorb with an inert dry material and place in an appropriate waste disposal container.

Large spill: Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations
